A. Get the ARRL General Class License Manual listed in item 1 above.

B. Get a pencil, highlighter, marking pen, or other writing instrument.

C. Print out the General Class License Pool questions – all 90 pages of it.

D. Start at question G1A01, look up the correct answer for each question, and mark it.

E. Repeat for each question until you have finish.

(Do not assume you know the answer. Look for it in the License Manual. Read it. Mark the question list with the correct answer.)

On the day of the Ham Cram bring the question pool with the marked correct answers with you. It will be your final preparation for the exam.

Applicants who successfully pass the General Class exam will be given the opportunity to take the Extra Class exam if they want to try it.
